



ICVCM TAGGING MANUAL FOR CCP ELIGIBLE PROGRAMS

1. PURPOSE

1. This Tagging Manual sets out the approach that CCP-Eligible Programs and the Integrity Council will take to ensuring accurate tagging (meaning identifying and labelling), of CCP-Approved carbon credits.
2. It builds on Section 4 of the ICVCM Assessment Procedure¹, as may be revised from time to time. Definitions used in this Tagging Manual are as defined in Section 5 Definitions², as may be revised from time to time. The contents of this Tagging Manual are not intended to impose additional rules or obligations on CCP-Eligible Programs and are intended to ensure that the requirements of the Assessment Procedure are implemented in a consistent and verifiable manner.
3. In the event of any inconsistency between (a) this Tagging Manual (b) the ICVCM Assessment Framework³ and/or the current version of the Assessment Procedure and/ or the Definitions, (b) shall prevail.
4. This Tagging Manual may be revised from time to time by the ICVCM, including to improve the workability of tagging, and based on feedback and experience and the operations and functionality of CCP-Eligible Program registries and stakeholder feedback, if any. All and any updates are at the sole discretion of the ICVCM. The ICVCM reserves the right to update this Tagging Manual to address costs of assuring the implementation and maintenance of accurate tagging by CCP-Eligible Programs.

5. The Terms and Conditions⁴ entered into by carbon-crediting programs apply to this Tagging Manual, as applicable. Carbon-crediting programs are not allowed to charge fees to any third party for labelling/tagging carbon credits as CCP-Approved under the ICVCM.
6. In accordance with ICVCM Assessment Procedure section 5.32, the termination of CCP-Eligibility of a carbon-crediting program means that, unless otherwise decided by the Governing Board and communicated in the relevant Termination Decision, no further carbon credits may be tagged as CCP-Approved or tagged with CCP Attributes and no new mitigation activities may be identified as CCP-Approved.
7. This Tagging Manual is a public document. It is addressed to CCP-Eligible Programs only and does not impose any obligations on other stakeholders of the ICVCM. No reliance may be placed on this document as it serves only to guide the implementation of the CCP-Approved carbon credit tagging aspect of the ICVCM Core Carbon Principles, Assessment Framework per the Assessment Procedure, by CCP-Eligible Programs.
8. The Integrity Council shall have no liability whatsoever (and whether contractual or non-contractual) arising out of or in connection with the implementation, application or operation of this Tagging Manual and no representation, warranty, undertaking or assurance, express or implied, is or will be made by the Integrity Council, its affiliates, associates, advisers, directors, employees or representatives or any other person as to the truth, accuracy, completeness, correctness or fairness of any tagging/labelling by any carbon-crediting program per the Assessment Procedure and/or this Tagging Manual.

CCP-Approved Carbon Credit Tagging and CCP Attribute Tagging

9. This section provides guidance by reference to the relevant provision of the Assessment Procedure.

⁴ The ICVCM Program terms and conditions are between the ICVCM and the carbon-crediting program and govern the application and oversight process, including dispute resolution procedures (per the Assessment Procedure).



10. There is a general assumption of good faith and reasonableness in this Tagging Manual, meaning that it is expected that the CCP-Eligible Program and the ICVCM will seek to ensure full and accurate implementation of the Assessment Procedure in relation to tagging by working in good faith and acting reasonably. This general assumption is without prejudice to the Terms and Conditions and the Assessment Procedure. As part of the oversight and assurance process, the ICVCM may require CCP-Eligible Programs to remove the CCP tag from carbon credits that have been tagged in breach of the Assessment Procedure, including erroneously.
11. Logo use in relation to tagging is undertaken in line with the ICVCM CCP Logo Use Policy⁵. Breaches of that Policy will be dealt with per that Policy.

4.1	A CCP-Eligible program may tag carbon credits as CCP-Approved where all of the following conditions are met:	<ul style="list-style-type: none"> It is expected that the CCP-Eligible Program will take all reasonable measures to identify all qualifying carbon credits and tag them as CCP-Approved. CCP-Eligible Programs are expected to have processes to manage queries around tagging, including related to Attributes, from relevant mitigation activities registered/issuing under the CCP-Eligible Program, including complaints and appeals. The CCP-Eligible Program will make publicly available information to explain how it will tag CCP-Approved carbon credits, including in relation to Attribute tagging. This information must include whether it will tag CCP-Approved carbon credits that have been retired prior to the CCP-Approval Decision.

4.7	In the event that any incorrect tagging is identified, the CCP-Eligible program will be required to correct the incorrect tagging within five working days and to notify the Integrity Council when the correction is completed. Managing CCP Attribute tagging in the context of related program own labels or other tags

12. Attributes can be used to identify additional features related to the mitigation activity for which the carbon credit has been issued. Such identification enables mitigation activity proponents to showcase the features of the mitigation activity and allows buyers to purchase carbon credits that match their preferences. To facilitate the identification of these additional features, the ICVCM has included CCP Attributes in the Assessment Framework.
13. Carbon credits that are CCP-Approved as a result of the assessment process may, in accordance with the Assessment Procedure, additionally be tagged with relevant CCP Attributes. A carbon credit may have more than one CCP Attribute, but each will be distinguished from other CCP Attributes that may be allocated to the carbon credit. Carbon credits that are not CCP Approved are not allowed to be tagged with CCP Attributes.
14. CCP Attributes are, therefore, optional for the CCP-Eligible Program, and it is the CCP-Eligible Program's choice whether to apply them to CCP-Approved carbon credits. CCP-Eligible Programs often have their own labels that are similar and sometimes equivalent to the CCP Attributes. These are called "own labels" in this Tagging Manual.
15. A CCP-Approved carbon credit could be entitled to none, one, two or three of the Attributes depending on the requirements being met. As CCP Attributes are optional, the CCP-Eligible Program may choose to use only one or two of the CCP Attributes.
16. Notwithstanding the above, a key consideration is how to avoid market confusion around the use of Attributes. The ICVCM will provide assurance and oversight over CCP Attribute tagging. The ICVCM will not provide assurance and oversight over the 'own labels' operated by a CCP-Eligible Program and will only provide assurance and oversight for the CCP Attribute elements of the 'own label' when the CCP-Eligible Program's own label encompasses the relevant CCP Attribute.
17. In this regard, Table 2 sets out considerations to be taken into account for each of the relevant CCP Attributes.



18. Information in the below table is in addition to information relating to the Assessment Procedure, set out in Table 1 above.

19. The CCP-Eligible Program will ensure the implementation guidance in Table 2 is in place before engaging in Attribute tagging, to avoid market confusion.
